1. Complete the document below, print it, and sign it.
2. The cost of an annual membership is \$150, and is good for 12 months from the purchase date.
  - a. Membership includes one access card, and property access for one vehicle and trailer.
3. Payment can be made in one of three ways:
  - a. Credit card over the phone.
  - b. Check by mail. (do not mail cash)
  - c. Credit card, check or cash in person, during normal business hours of The Station House.
4. If paying over the phone:
  - a. Call Zac at 573-777-5500
  - b. Payment will be taken over the phone.
  - c. The form can be mailed in using the address below, or submitted by email to [boats@katfishkatys.com](mailto:boats@katfishkatys.com)
  - d. Your card will be mailed via USPS within 24 hours of receiving both payment and a completed agreement form.
5. If paying by mail:
  - a. Place completed form and payment into envelope.
  - b. Address to:

    - ii. Once form and payment are received, an access card will be mailed via USPS within 24 hours.
6. If paying in person:
  - a. You will be given an agreement form to complete at the time of purchase.
  - b. Payment will be processed on site, and an access card given immediately.
7. Payment in full required to receive an access card.

**RULES & REGULATIONS: Licensee hereby agrees to abide by all rules and regulations listed below:**

1. No camping, hunting, overnight parking or fires permitted on property.
2. Prior approval by Licensor required for boat launches greater than 24-hours.
3. Trash shall be deposited in provided containers.
4. NO swimming, floating or diving permitted in water adjacent to ramp or facilities.
5. Ramp users shall conduct themselves in an orderly, courteous & respectable manner at all times. Licensee is responsible for any guests.
6. Outsiders are not allowed on property without being accompanied by the boat owner or member of the boat owner's immediate family.
7. License can't be assigned or transferred to others without consent from Licensor.
8. Licensee or guests shall not cause any damage to the property or gate.
9. Licensee acknowledges that Licensor will not be responsible for any loss or damage to Licensee's boat, trailer, vehicle or any other property of Licensee or guests brought on property.
10. Licensee assumes all risk and liability for injuries to himself/herself, family or guests, property damage or loss of life or property resulting from, or in any way connected with, the use of the boat ramp, water or facilities and agrees to fully indemnify and hold harmless Licensor with respect thereto, including any legal expenses and other costs of Licensor.
11. Replacement swipe card available for \$15. The old card will be deactivated at the point of new card activation.
